Courts evaluate both good faith provisions through a subjective inquiry into the totality of the circumstances in each case, typically using similar factors ...

Proposed in good faith. Section 1325(a)(3) of the bankruptcy code requires the chapter 13 plan to be proposed in good faith and not by any means prohibited by law for it to be confirmed by the court. Unless a creditor objects to the chapter 13 plan, the bankruptcy court is allowed to find that the plan was proposed in good faith without receiving evidence on the issue.

Good Faith in Chapter 13 Bankruptcy
Once the initial chapter 13 plan is confirmed, most courts will consider the issue of the debtor's good faith in filing the case to have been finally determined. Similarly, the running of the 60 day non-dischargeability complaint deadline will prevent a creditor from ever raising this issue later.
