It is a 2-part exam and most candidates aim to finish within one year. Candidates can take the exam anytime within the testing windows, which opens 6 months out of each year. In order to become a CIMA, the candidate must pass the 12 papers, complete at least 3 years of qualifying practice, and obtain verification and endorsement from supervisors.
