The law is if the parent who is paying child support can provide medical coverage for the child at a reasonable cost (not to exceed 9% of annual gross income), and dental insurance at a reasonable cost (not to exceed 1.5% of annual gross income), that parent must provide medical and dental coverage for the child.

Guidelines are revised annually. If your household appears close to qualifying, please contact CAC at (360) 438-1100 to speak to a CAC representative. To qualify for weatherization services, the gross income received by all household members must be at or below 200% of the federally-established poverty guidelines or 60% of State median income.
