File as Head of Household . Filing as head of household on your tax return provides two benefits for single parents: You'll be able to claim a higher standard deduction, and you can earn more than single filers before you move into the next higher tax bracket. The standard deduction for head-of-household filing status is \$18,650 for 2020, the tax return you'll file in 2021.

### Tax Breaks for Single Parents - The Balance

The 2017 Tax Cuts and Jobs Act changed the rules for claiming the moving expense tax deduction. For most taxpayers, moving expenses are no longer deductible, meaning you can no longer claim this deduction on your federal return. This change is set to stay in place for tax years 2018-2025.

Federal tax law does not require you to take all credits or deductions that you are legally entitled to. Unusual, but there is no penalty for not taking a tax break you are entitled to.
