Under Florida's statute of limitations for personal injury cases, you have four years from the date of the accident to file a lawsuit in Florida's civil courts (this law can be found at Florida Statutes Annotated section 95.11 (3)). If you don't file your case within this time window, the court will very likely refuse to hear it at all.
