Code services provided on or after Oct 1, 2015 with ICD-10; Code services provided before Oct 1, 2015 with ICD-9, even if you submit the claim after Oct 1, 2015; The ICD-10 transition is a mandate that applies to all parties covered by HIPAA, not just providers who bill Medicare or Medicaid.
