ARCHOICES Section II

Pursuant to Mississippi Code Section 93-11-103(13), employers are required to report lump-sums paid to employees of over \$500 to the Department of Human Services if the employer has been served with a withholding order that includes a provision for the payment of arrears. Lump-sums are defined in Mississippi Code Section 93-11-101(l).
