The American Bar Association Model Code of Professional Responsibility, created by the American Bar Association (ABA) in 1969, was a set of professional standards designed to establish the minimum baseline of legal ethics and professional responsibility generally required of lawyers in the United States. It was replaced with the Model Rules of Professional Conduct in 1983 for a number of reasons, especially the Watergate scandal.

The Model Code of Professional Responsibility points the way to the aspiring and provides standards by which to judge the transgressor. Each lawyer must find within his own conscience the touchstone against which to test the extent to which his actions should rise above minimum standards.

Legal Definition of ABA Model Code of Professional Responsibility guidelines adopted by the American Bar Association in 1969. The Model Code is organized around nine canons, or standards of professional conduct for lawyers, with sections called ethical considerations and disciplinary rules following each one.

In May 1993, NFPA adopted this Model Code of Ethics and Professional Responsibility ("Model Code") to delineate the principles for ethics and conduct to which every paralegal should aspire. The Model Code expresses NFPA's commitment to increasing the quality and efficiency of legal services and recognizes the profession's responsibilities to the public, the legal community, and colleagues.

This Code attempts to define and illustrate that responsibility in terms of a lawyer's professional relationships with clients, the Justice system and the profession. CODE OF PROFESSIONAL RESPONSIBILITY (Promulgated June 21, 1988) CHAPTER I. THE LAWYER AND SOCIETY. CANON 1 - A LAWYER SHALL UPHOLD THE CONSTITUTION, OBEY THE LAWS OF THE LAND AND PROMOTE RESPECT FOR LAW OF AND LEGAL PROCESSES. Rule 1.01 - A lawyer shall not engage in unlawful, dishonest, immoral or deceitful conduct.

The California Rules of Professional Conduct are intended to regulate professional conduct of attorneys licensed by the State Bar through discipline. They have been adopted by the Board of Trustees and approved by the California Supreme Court pursuant to statute to protect the public and to promote respect and confidence in the legal profession.
